# **TET Grants Budget vs Actual**

The report Grants Approved Y/E 30/06/21 (as at 31/03/21) had previously been circulated to the Trustees.

The following was noted -

There was little change to the previously circulated report.

The \$500,000.00 grant to the SDC had been backed out of the report as the funding was approved from the reserve fund.

The NTSRI GST refund had been added back in.

Actual grants approved year to date was sitting at \$2.2M and the budget was \$3.2M.

Mr Hassall reminded the Trustees of the letter sent to the SDC advising that should there be any surplus between the TET grants budget and the TET grants approved for the current financial year, the SDC could lodge an application of up to \$500,000.00 for pool costs and that this could be in conjunction with the SDC submitting a funding application in the \$100,000.00 and over 2021 funding round.

It was agreed to send a letter to the SDC asking their intention regarding the above; letter to also enquire if there is any update on naming rights. It was further agreed that the SDC reply would negate the need for the organisation to lodge another application for this request. A reply would have to be received by Thursday, 10 June in order to be considered prior to the TET's financial year end.

# Replacement of TET Trustee Mid Term

The policy had previously been circulated to the Trustees. It was agreed to wait until all 6 Trustees were present at a meeting before adopting the document.
