#### 14. Stratford & District Scottish Society

After discussion, Mr McDonald moved and Mr Bedford seconded that and under-write of \$75,000.00 be awarded for the hosting of the 2026 Royal New Zealand Pipe Band Association national contest in Inglewood, providing a more detailed business plan and budget is provided.

Mrs Stevenson moved and Mr Erwood seconded an amendment for an additional \$3,800.00 to purchase 12 chanters, in addition to the \$75,000.00 under-write. The amendment was put to the meeting and carried. The amended motion then became the substantive motion and was put to the meeting and carried. Stevenson/Erwood

#### **Inglewood Welfare Society Incorporated**

Mr Waite, Mrs Loveridge and Mr Rajun spoke to their previously submitted report and grant request. While trading has improved significantly, there remains various challenges and risks moving forward. The Trustees discussed various aspects of the existing loan and the request from the IWSI.

Mr McDonald moved and Chairman Davey seconded that a grant of \$2,000,000.00 be awarded to enable the repayment of the \$2,000,000.00 loan.

Mr Bedford moved and Mrs Stevenson second a foreshadow amendment that if the original motion is defeated, then the IWSI loan will be interest-free and principal-free until 30 November 2025.

The original motion to grant 2,000,000.00 to enable the repayment of the \$2,000,000.00 loan was put to the meeting and carried.

#### **Age Care Central Limited**

At 10.56am, Michael Walsh, Jo Russ, Helen Jones and Doug Robinson (Age Care Central Limited) joined the meeting and discussed their previously submitted report, the financial results and forecast for the coming year. There are a number of uncertainties that the entity face. The make-up of residents (rest home, dementia and hospital) has had and continues to have an impact on the cashflow.

It was anticipated that the shareholding in Age Care Central Limited was going to be passed from Marire Home to the Stratford Health Trust. But this is now on hold. It was also noted that there are currently four chalets, owned by TET Holdings, for sale.

Michael Walsh, Jo Russ, Helen Jones and Doug Robinson left the meeting at 11.26am.

It was resolved to extend the period of interest-free and principal-free to 30 September 2025, and to permit a bank to take a first-ranking GSA in preference to TET, up to the level required to obtain an overdraft of up to \$200,000.00.
