TET Grants Budget for the year – Budget vs Actual

The report 'Grants Approved Y/E 30/06/24 (as at 31/08/23)' had previously been circulated. The report was received.

Age Care Central/Inglewood Welfare Society

The August reports for both organisations were discussed. Chairman Davey will prepare a paper on the future directions of the existing term loans. The Trustees agreed that the direction of these needed to be consistent with the Trust Deed review.

Bishop's Action Foundation

At 9.55am Andrew Brock and Simon Cayley of the Bishop's Action Foundation joined the meeting.

They gave an overview of the organisaiton and the work that has been done in the area thanks to prior TET support. They have had a reduction in funding from the TOI Foundation for the work undertaken by the Wheelhouse. They would like to have a dedicated person in the TET area to assist. The new Incorporated Societies Act will mean a number of the 200+ organisations in the area need assistance with re-registration. 78 children have benefited from the Season's for Growth programme.

Mr Brock and Mr Cayley left the meeting at 10.20am.

Taranaki Masters Games

Mr Erwood declared a conflict of interest.

Proposals from Sport Taranaki and Athletics Taranaki were discussed.

It was agreed that the Chairman speak with Sport Taranaki

- a) With the view of developing a 3-5 year transition plan for the event.
- b) Producing a more refined budget.

In addition, all venues must be within the TET area and an annual application for funding would be required.

Funders Forum

It was noted that a forum is being held in Stratford on October 7. The Chairman will decide whether the Trust will be represented at this forum.

\$100,000 and over grants

It was agreed that the following organisations will be visited on October 2: Stratford District Council, Inglewood Dramatic Society, Bowls Waitara, Marine Park (NPDC) and Nga Pekanga Catholic Maori Charitable Trust. Mr Hassall will make the necessary arrangements.

The Taranaki Environmental Education Trust will be invited to the October meeting.

It was agreed that the Toko Rugby Football Club application, given the size of the requested amount, should not proceed until the Club is incorporated.
