Erwood/Bedford

Inglewood First Trust

Marie Pearce of the Inglewood First Trust joined the meeting at 8.55am.

Mrs Pearce spoke in support of previously circulated documentation on the prospects of a new ice skating rink, which could be constructed in Inglewood. A feasibility study is required for the project. Mrs Pearce asked that TET support the study to the tune of \$35,000.

Mrs Pearce left the meeting at 9.12am.

After discussion, the meeting agreed that the correct process must be followed, and Inglewood First Trust be required to submit an application and a copy of the resolution of the Trust to apply for a grant.

TET Grants Budget for the year – Budget vs Actual

The report 'Grants Approved Y/E 30/06/23 (as at 30/06/23)' had previously been circulated. The report was received.

After discussion, it was resolved that the grants budget for the new financial year be \$4,000,000.

It was agreed that that schools/playcentres/kindergartens will have a budget of \$300,000, scholarships \$50,000 and other education \$70,000. A new category of environmental will be established. Mr Hassall will reallocate prior grants into this new category.

Specific policies for the education, scholarships and environment will be workshopped on 9 August 2023 by Trustees from 4pm. This workshop will also discuss previously circulated policies, procedures and application forms.

Collaborating for Active Spaces

Chairman Davey updated Trustees on the discussion he had had with Marina Healey (Sport Taranaki). Correspondence on Taranaki Facilities Consortium was also discussed. It was agreed to invite Selwyn Metcalfe (NZCT) and Maria Ramsay (TOI) to the September meeting.
