The updates were discussed. It was agreed that Mr Davey will speak to the Inglewood Welfare Society about the prospect of a consultant.

Investment Portfolio review

Michael Chamberlain joined the meeting via Zoom at 10am.

Mr Chamberlain briefed the Trustees and answered questions on the following:

- The Reserve Bank belief that they could control interest rates to contain inflation has resulted in interest rates increasing, but this in turn has reduced the value of bonds. However, bonds will have higher future returns because of this.
- As there are still wage pressures, inflation, while it may go down in the short term, will still be volatile.
- The Portfolio return of \$3.97M to 30 June 2023 represented 4.12%.
- The return on overseas shares was only 1.31%, which was below market. It is important that the SIPO and mandates are reviewed on overseas shares and the overall portfolio. This was last done in 2020. It was agreed to do this later this year.
- Pioneer Capital are now offering a private debt fund, which promises a higher yield than private equity. Mr Chamberlain will provide more details on this in due course.
- Some organisations have an enthusiasm to invest in organisations with a better carbon footprint.
- AML for all Trustees will need to be updated again.
- Getting into overseas private equity is difficult because significant sums are required to invest. There are some options in Australia. Locally, Direct Capital is performing well, but Pioneer Capital has struggled.

Mr Chamberlain left the meeting at 10.25am.

It was agreed, subject to Mr Chamberlain's availability, that he attend the 15 November 2023 meeting. He will be allocated one hour from 10am, with the meeting commencing at 8.30am.

Mr Hassall advised that organisations were expected to submit their intentions prior to the September meeting.

Bishop's Action Foundation

It was agreed to invite the Bishop's Action Foundation to the September meeting.

\$100,000 and over grants
