TET acknowledgement

It was agreed that the application form would be updated to include a section where applicants advise what promotion was provided to TET from their previous grant.

Taranaki Trails Trust

Darryl Gaudin and Ian Armstrong of the Taranaki Trails Trust joined the meeting at 9.46am

The Trust has been established to produce a great ride in Taranaki. The proposed Waitara loop has involved discussions with the community board, hapu, NPDC and the TRC. Letters of support have been obtained. The two loops will be safe and hard-wearing, with no heavy earthworks required. Once

constructed, maintenance will fall back to the NPDC. Ideally, construction will be completed by the end of the year, funding dependent.

Mobility scooters

The excellent efforts of the mobility scooter agencies was acknowledged. In recognition of the the operational costs that the organisations incur in providing the services, it was agreed to award grants to the agencies as follows: Eltham (\$5,000), Stratford (\$10,000), Inglewood (\$5,000) and Waitara (\$10,000).
