TET Grants Budget for the year - Budget vs Actual

The report 'Grants Approved Y/E 30/06/23 (as at 31/01/23)' had previously been circulated Mr Hassall advised it was likely the grants budget would be exceeded. The report was received.

Quarterly financial report

Mr Hassall spoke to the previously circulated financial statements and investment portfolio report to 31 December 2022. Both reports highlighted the current volatility in the international market particularly. The reports were received.

Trust deed review

The meeting noted the correspondence from Connect Legal regarding the Trust Deed, which they have commenced a review of. A legislative review is occurring first.

ACCL

It was noted that the project is starting to progress well now. Mr Upson's report was received.

BRASA Waitara Brazilian Jiu Jitsu

The current position of the club was discussed. Mr Bedford will ask the club to submit an application by February 20 to be considered at the March meeting.

Inglewood Welfare Society (IWS)

The current position of the organisation was discussed.

It was agreed that Mr Hassall would write to both IWS and ACCL acknowledging the difficulties especially around staffing recruitment and retention and what can be done to assist in this direction.

At 10.28am, Denise Loveridge and Nikki Valentine of IWS joined the meeting.

They spoke about the pressures of operating under Covid-9, staff difficulties, expense increases and working capital shortfalls. The kitchen upgrade appears to be on budget but there is no absolute guarantee. Sustainability is improving as occupancy rates increase. Currently 28 of the 31 rooms are occupied.

Denise Loveridge and Nikki Valentine left the meeting at 10.46am.

It was agreed that no additional support be provided at this time for the kitchen upgrade.

It was resolved that IWS be provided with a 12 month interest-free and principal-free period for its current loans. This will cover the period 1 January 2023 to 31 December 2023. It is contingent upon suitable monthly financial reports being received. This will be reviewed in December 2023.
