Mr Metcalfe said he respected the previous TET decision to not be involved with the Regionals Sports Facilities Group, but would like it to be reconsidered. Working together and talking through projects/applicants is needed.

The Trustees preference is for community projects being put together by the community for the community and that funders deal with funders on these projects.
